Notice is hereby given that the polling places below will be open from 7:00 a.m. to 7:00 p.m. on November 3, 2020 for voting in a special election to consider the following propositions:

**PROPOSITION A**

Shall the Commissioners Court of King County, Texas be authorized to issue bonds on behalf of the Guthrie Common School District, in one or more series, in the aggregate principal amount of \$785,000 for the purpose of constructing, acquiring, renovating, and equipping school buildings in the School District and the purchase of new school buses, with the bonds to mature, bear interest, and be issued and sold in accordance with law at the time of issuance, all within the discretion of the Commissioners Court; and shall the Commissioners Court be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the School District, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the cost of any credit agreements executed in connection with the bonds?

**(PROPOSICIÓN A)**

*¿Deberá la Corte de Comisionados del Condado de King, Texas, recibir la autorización para emitir bonos a nombre de Distrito Escolar Común de Guthrie, en una o más series, por un monto total de \$785,000 con el fin de construir, adquirir, renovar y equipar los edificios escolares en el Distrito Escolar y la compra de autobuses escolares nuevos, con bonos con vencimiento, que generen intereses y que sean emitidos y vendidos de conformidad con la ley al momento de su emisión; todo lo anterior a discreción de la Corte de Comisionados; y deberá autorizarse a la Corte de Comisionados para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito Escolar de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos y el costo de cualquier contrato crediticio celebrado en relación con los bonos?)*

**PROPOSITION B**

Shall the Commissioners Court of King County, Texas be authorized to issue bonds on behalf of the Guthrie Common School District, in one or more series, in the aggregate principal amount of \$290,000 pursuant to Chapter 45, Texas Education Code, for the acquisition or refinancing of property financed under contracts entered under Subchapter A, Chapter 271, Local Government Code, to wit: Public Property Finance Act Contract No. 8988 dated January 31, 2020 between Guthrie Common School District and Government Capital Corporation, with said bonds to mature, bear interest, and be issued and sold in accordance with law at the time of issuance, all within the discretion of the Commissioners Court; and shall the Commissioners Court be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the School District, sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds and the cost of any credit agreements executed in connection with the bonds?
